- Profit after CIT of quarter 3/2025: 41,510,227,207 VND.
- Profit after CIT of quarter 3/2024: 24,493,257,995 VND.

Profit after CIT of quarter 3/2025 was increased compared to the quarter 3/2024 with an amount of 17,016,969,212 VND.

The main reason leading to an increase in business result of quarter 3/2025 compared to quarter 2024 was as follows:

In the quarter 3/2025, Capacity of water flowing to the Hydropower reservoirs of SBA was more than that of the quarter 3/2024, so quantity electricity generation and revenue increased respectively by 78.87% and 42.62 billion VND over the same period in 2024. So profit after CIT of quarter 3/2025 has been increased 17.02 billion VND, compared to quarter 3/2024, which was equivalent to an increase rate of 69.48%.
